

If the land of the college is of agriculture then after receiving the copy of conversion certificate/use certificate issued by the competent authority, be sent to the office.

Besides this the below mentioned instructions/directions be also followed:

1. An endowment fund amounting to Rs.10/- Lac may be deposited with the University immediately in the form of F.D.R. in the name of Dean, College Development Council, Punjabi University Patiala.
2. An affirmation fee amounting to Rs.50,000/- may be deposited with the University in the form of Demand Draft in the name of Registrar, Punjabi University, Patiala.
3. The college will be bound to pay the affirmation fee for each course as to be decided by this university later on.

4. The college will have to deposit the affirmation continuation fees every year as per University norms, latest by 31 August.
5. The College building will not be used for any other purpose.
6. College once affiliated to this University, will not seek affirmation to any other University for any course(s)/subject(s).
7. The college will impart instructions as per University syllabus.
8. The teaching staff will be appointed as per U.G.C. qualifications through a duly constituted selection Committee under the rules.
9. The College will seek affirmation/approval of the University for the second/third part of the course to be started w.e.f. session 2006-07 and 2007-08.
10. The college will send cases of approval of the appointed principal/Faculty/Librarian within one month from the date of their appointment.
11. The college may not without the previous permission of the Academic Council, suspend instructions in any subject or course of study for which it is authorized to impart instructions.
12. The college shall have a regularly constituted Governing body consisting of not more than twenty persons including, among others, two representatives of the University, and the principal of the college ex-officio. The term of the University representatives will be three years. It may be ensured that the University nominees are invited in governing body meetings.
13. The college shall pay salary to the faculty in the UGC grades as adopted by the Punjabi University Patiala. An affidavit to this effect, signed by the President of the Foundation/Trust/Society, and duly attested by the Magistrate (First Class), will be submitted to the University. The college will maintain the proper records of the salary of the faculty and staff.
14. The college will charge tuition fee and other charges as prescribed by the University.
15. The college will be bound to abide by University rules issued from time to time, failing which the affiliation may be withdrawn.


So you are requested that after completion of the above said conditions issued by the University, the detailed report be sent to the office and in continuation the above said instructions be followed.
