Sub: To give the sanction to the Young/Youthful Education Society falls under the Punjabi University Patiala, to start the New Degree College at Village Chuni Kalan since 2006-07.

In reference of subject cited above of your Memo No.14/120-05 K-Edu(1) 2469 dated 3-11-2005.

2. The sanction to start the Young Education Society into Dolphin (P.G.) Institute of Life Science with different subjects from 2006-2007, situated at Village and Post office Chuni Kalan, Distt. Fatehgarh Sahib which falls under the jurisdiction of Punjabi University Patiala, under education and Post Graduate (Science Group) is being given on the conditions stated below:

1) The expenditure which will be held on the new subjects/to start the new course, the same will be bear by the concerned administration committee from its own sources and The Government will not be responsible in this regard.

2) The report of the Observer committee sent by the concerned University should be in positive.

3) The counting of new subjects/ admissions in the courses, will be fixed by the Observer committee of the University.

4) The permission will be given by the University to start the new subjects/courses, if the required and approved syllabus will be prepared.

5) In this connection the conditions imposed by the College University will be completed and other facilities would be provided as per the conditions fixed by the Govt and university.

6) The institution will arrange the land, building, library and other material to continue the institution/college from its own funds and without the help of the Govt.

7) That this permission will be temporarily.

In spite of the above said conditions, the sanction of the building will be approved from the concerned authority and to make sure the certificate from the concerned authority to use the land for open the college.
